

# 8. Parish Statement and Financial Report

- Parish Giving has dropped by £3K
- We've had 2 Council grants; 1 for £3k towards lose of Family Centre rents and 1 for £4,261 for the new front doors to the Family Centre.
- Recoverable Tax has also gone done this is the tax we can recover from small donations (e.g donations at Wedding/Funerals)
- Pre-School were 1<sup>st</sup> back in the Family Centre but they aren't doing the same hours, however, heating/lightening costs are still high.
- Dogs Trust are also back on Friday evenings
- Family Centre expenses look high due to the cost of the new door.
- We have paid £62k Parish Share. This is £17k less than the Diocese requested. We couldn't meet the full amount due to loss of income. We are not the only Parish not meeting its full Share.
- Historically we have a Charity called CSC Arnold which lent £3k to St Mary's. There was still £349 in the account but the bank wanted to charge £5 a month for the account so that money is now incorporated in Church funds. It's hoped that one day the Charity maybe able to form again.
- Due to a mixture of Brian's laptop having 'died' making production of the accounts later than usual and also the Examiner being ill, the Examiner hasn't had an extensive look at our accounts this year. This will be done as soon a the examiner is well enough.

Alan Langton offered Thanks to Brian for always doing his job quietly, consistently, and effectively.

# 10. Churchwarden Report

# **Family Centre**

Over the year as covid restrictions were gradually lifted the groups who hire the Centre have returned. Preschool have returned to 5 mornings a week. But not Wednesday afternoon Dogs trust have returned on Friday evening.

Table Tennis have returned to Monday afternoons and Thursday evening. Rocksolid and R2 have returned on Sunday evening. Mothers union, Senior teas, Messy Church, Tots and Cinema are back to their monthly meetings. Church groups do not pay to use the hall.

Community Kitchen is going well on Saturday mornings. Thanks to Ron and Karen Price. Please see separate report.

The uniform groups have returned apart from Monday evening Sadly Four Seasons has had to finish. Numbers were very low and it wasn't viable. It was founded many years ago by Rev. John Banks. Sue Baxter, and Joyce Hellebaut have continued to run the group for many years with volunteers, providing a hot meal, fellowship and trips out. Thanks to all those who have supported Four Seasons over the years. Hopefully there may be an article about it's history in Compass at some point.

The hall has had its 5 yearly electrical test this year plus the usual Fire and alarm tests. PAT testing has also been carried out. Some remedial work is necessary which will be carried out in due course.

#### Church

Church is due for a 5 yearly wiring test next year.

Church is in a good state after the tower, roof, and rainwater goods have been tended too recently.

The interior is clean and tidy with a few minor remedial works to be carried out.

After the great covid sort out some things have not found their way back into church. This will be done ASAP

Covid guidelines have gradually been relaxed over the year along with Church and government guidelines.

Wearing of masks, sanitizing and communion in one kind is still in operation (2021).

Vicar Margaret has had time off during the year due to illness. Towards the end of the year she decided to retire and leave St Mary's in March 2022.

At the end 2021 she was unable to work and during this absence Canon Sylvia stepped in and kept our 9am Holy Communion Sunday services going with help from a few retired priests. The monthly 10:30 Communion services were done by Sylvia and the Moring Worship by a group from the congregation organised by Larrie.

During the year we had a mixture of zoom services and meetings.

Huge thanks to Sylvia and Angela for all they have done keeping the services going.

We changed our service pattern in August for a 12 month trial.

# 12. Group Reports

Afternoon Teas & Tots are still running, and both well attended Children Groups in Church on Sunday aren't currently running, but it's hoped to start again soon. During 2021 the children were given packs that they could do on their pew due to the restrictions.

# **Safeguarding**

The PCC has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 (duty to have regard to House of Bishops' guidance on safeguarding children and vulnerable adults).

Larrie Thompson is currently in the process of handing over responsibility to Kirsty Aplin.

We have a safeguarding, social media and photograph policy – all of which require renewed approval by our PCC in September 2022. We currently have no Safeguarding issues.

# 13. Any Other Business

John Allister asked that everyone take a few minutes to talk to their neighbour about what, at St Mary's, they were grateful for in 2021.

Alan Langton asked what the CoE ruling was regarding Communion Wine. John explained that individual churches can now reintroduce the Common Cup if they have done a risk assessment. It is the decision of the Incumbent, (or Area Dean). PCC/Standing Committee could make this decision and John would support it. Individual cups are NOT permitted; however, some churches do have 'household' cups (paper cups!).

The St Mary's Parochial Church Council (PCC) has the responsibility of co-operating with the Vicar in promoting in the ecclesiastical parish the whole mission of the Church of England, pastoral, evangelistic, social and ecumenical. The primary object is the promotion of the Gospel of our Lord Jesus Christ according to the doctrines and practices of the Church of England. The parish of Arnold is a large urban parish on the north east side of Nottingham based on the northern part of the Old Urban District Council area of Arnold, the population of this is some 24,000. The clergy stipends together with housing costs are paid by the Church Commissioners and are not reflected in these accounts. The base and work centre is the Church of St Mary, situated in Church Lane, Arnold which is a stone building dating back some 700 years and the freehold of this is vested in the Diocesan Board of Finance of Southwell and Nottingham. On land next to and held by the Church was erected in about 1965 the building known as the Church Hall (or Family Centre) and this has received a major rebuilding. The PCC own 22 St Mary's Close which is now being rented after it had been used as a base for the curate in the parish.

The country was affected less by the coronavirus infection which was reducing in levels of infection. Government regulation designed to limit the spread of the disease limited activities.

Details of the main services are shown on Page 13

The church encourages groups for fellowship and outreach and these include house groups, Alpha courses and youth and children's groups.

The PCC is a corporate body established by the Church of England .The PCC operates under the PCC powers measure. The PCC is registered with the charity commissioners.

The Parochial Church Council met on the 3 February, 26 April, 17 May, 12 July, 13, September and 1 November. Additional meetings were held to process the vacancy.

Five (now four)members are elected each year to the council for a three year term at the Annual Meeting. Others may be co-opted. The appointment of PCC members is governed by and set out in the Church Representation Rules.

#### **COMMITTEES OF ST MARY'S CHURCH ARNOLD**

The PCC operates through the standing committee between full meetings of the PCC.

# **Standing Committee**

Chairman – The Vicar (until March 2022)

The other committee members are: Church Wardens – Ian Rosillo (from APCM), Angela Davidge (from APCM) and David Rodgers (to APCM) and Liz Turley (to APCM). PCC Secretary Larrie Thompson and PCC Treasurer Brian West. It has power to transact the urgent business of the PCC between its meetings and is the only committee required by law.

# **Community Street Care-Arnold (CSCA)**

This charity was set up in March 2012 by a group of church members. The object of the charity is youth and community work in Arnold. As a condition of receiving an initial grant from the diocese it was necessary to agree that the trustees would be appointed by the PCC. The present trustees are Larrie Thompson, Michael Bolton, Brian West David Rodgers and Peter Spencer. This has been dormant all year.

#### **OBJECTIVES AND ACTIVITIES**

The PCC is committed to enabling as many people as possible to worship at the church and to become part of the parish community. Our services and worship put faith into practice through prayer and scripture, music and sacrament.

We try to enable ordinary people to live out their faith as part of our parish community through

a) Worship and prayer, learning the gospel and developing their knowledge and trust

in Jesus

- b) Provision of pastoral care for people living in the parish
- c) Missionary and outreach work.

To facilitate this work it is important that we maintain the fabric of the Church of St Mary and the Church Family Centre.

#### **SUNDAY SERVICES**

09.00 am Parish Communion traditional Common Worship except one Sunday a month Book of Common Prayer. No service at this time on joint service Sundays

10.30am Morning Worship (Informal) with usually one Sunday per month a joint Communion service (usually 3<sup>rd</sup> Sunday).

# ST. MARYS CHURCH, ARNOLD FINANCIAL REVIEW OF THE YEAR

The accounts are affected by the cautious approach to the relaxations now available by the government. The population continued to a large extent to avoid group meetings particularly in the early part of the year.

The Church's main source of income is the planned giving which has for many years been operated through a gift aid scheme, a full renewal of which took place in September 2017. The amount received in 2022 was £46,508. The scheme basically encourages the payment of regular giving, usually by means of bank standing order or giving envelopes, with the view that income tax is recoverable on the giving under Gift Aid. Other normal income consists of collections both at normal services and specific services such as in respect of weddings and funerals. We were able to reclaim tax on various sources of income to a total of £16,685.

The principal item of expenditure is the parish share. This is an apportionment of the costs of the Diocese of Southwell and Nottingham based on their actual and potential Church membership and ability to give. The amount finally apportioned to Arnold by the Gedling Deanery for the year to 31 December 2022 was £86,252. We paid £60,000 leaving £26,252 unpaid. The amount requested for 2023 is £87,456. The PCC is responsible for the maintenance of the church building and for clergy expenses. The church was insured for fire during the year for some £11,180,000.

The other main items of income and expenditure relate to the Church Hall (or Family Centre). This is now insured for fire during the year in the sum of some £3,000,000

This is mostly let to church related organizations and receipts from this are shown at some £12,758 for the year. The cost of maintaining the building was £16,109.

Group meetings have not returned to normal. .

The total church expenditure for the year was £101,768 and the total income was £114,010 leaving a surplus of income over expenditure of £12,242

The PCC own a property at 22 St Mary's Close for church use. It was donated to the parish for use by a curate and is now being rented as no curate has been allocated by the diocese. It is insured for rebuilding costs of £238,645

Grateful thanks must be offered to the many members who do unpaid work to enable the church to function so effectively.

# ST MARY'S CHURCH, ARNOLD, NOTTINGHAM ACCOUNTING POLICIES

The financial statements have been prepared under the Charities Act 2011 and in accordance with the Church Accounting Regulations 2006 governing the individual accounts of PCC's together with applicable accounting standards and the current Statement of Recommended Practice, Accounting and Reporting by Charities (SORP102).

The financial statements have been prepared under the historical cost convention.

# **Fund Accounting**

Unrestricted funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC.

Restricted Funds comprise revenue donations and grants for a specific PCC activity intended by the donor. The appeals in respect of work on the tower/roof and the organ are restricted funds. Three small items have to be completed on the tower

which although started early in the year had to be halted for a period in the spring to meet government regulations. One donation by agreement has been used to meet the shortfall on the house at St Marys Close when acquired.

Designated funds are general funds set aside by the PCC for use in the future.

The accounts include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body or those that are informal gatherings of church members.

### **Incoming Resources**

Planned giving, collections and similar donations are recognized when received. Tax refunds on gift aid donations are recognized when the donation is received.

#### Other Income

Rental income from the letting of church premises has been recognised when the rental is paid

#### **Resources expended**

Diocesan parish share is accounted for when paid

#### **FIXED ASSETS**

# Consecrated property and Movable Church Furnishings

Consecrated and beneficed property is not included in the accounts in accordance with s.10(2)(a) and (c) of the Charities Act 2011.

Movable church furnishings held by the vicar and churchwardens on special trust for the PCC, and which require a faculty for disposal, are inalienable property listed in the church's inventory which can be inspected (at any reasonable time). For anything acquired prior to 2000 there is insufficient cost information available and therefore such assets are not valued in the financial statements. Subsequently no individual item has cost the church more than £1,000 so all such expenditure has been written off when incurred.

#### **CHURCHWARDENS' REPORT FOR THE YEAR 2022**

#### Church

As we said in our Parish Profile, the last few years have not been easy for our church, but I think we can now say that 2022 has been a year of coming together and moving forward with expectation.

We are hugely grateful to Sylvia Griffiths who has not only continued to prepare, lead and hold together our services, but has also conducted all of the baptisms, weddings and funerals, of which there have been many! For us as churchwardens and for all of us in church she has enabled us to grow together and move forward, and we are sure that we speak for the whole church in saying that we are immensely grateful to God for the gift of Sylvia during this past year. We also want to say a big thank you to Alan Langton who has continued to lead some of our 9am. services as well as some of the 10.30am worship. Huge thanks too to Larrie and Brian who have also helped to lead some of the 10.30 worship.

During the year we have maintained a regular pattern of services and our monthly Joint Service has brought the two congregations together and we have experienced a variety of styles of worship. As a church we responded really generously to our Advent Challenge to bring an item for the Foodbank each week and this is ongoing. In addition, support for Christian Aid and the Leprosy Mission has continued. We have had opportunities for social events to enjoy fellowship together, Lent lunches, an Afternoon Tea and an Advent lunch – these have all been well attended and a further opportunity to be together as a whole church family.

As a church we are blessed in having so many people doing different jobs in the church, often behind the scenes but who help enhance our worship, the beauty and the smooth running of our church building, and our activities and make life much easier for Sylvia and for us as a churchwardens! No task or role is more important than any other and we each have different gifts, but what we have seen this year is all of us working together as the Body of Christ and we want to say a huge than you to each and every one of you.

# **Church and Family Centre Fabric**

The Church and Family Centre's fabric has remained in good order during the year with no quinquennial inspection due, however we have invested in both to make the experience of using them better. We continue to be grateful to the Hammond family for their work in maintaining the church and vicarage grounds so well.

#### Sound system

During the year we have had a detailed investigation of the sound system in Church with the help of the Electric Bear company from Mansfield. The sound desk has been replaced by a smaller digital control unit and the wiring and connections have all been checked. Additionally, the sound engineers have helped us position the microphones in church more effectively so that readers can be heard more clearly. We were very fortunate in that an anonymous benefactor paid for most of this work.

There is still more work to be done. The hearing loop system has been affected by the new sound desk and needs further adjustment and one speaker at the front is not working, an investigation is in hand to try and repair that. Overall, it is now much easier to hear people participating in services. We are also investigating the possibility of installing more electronic screens in church, the difficulty is connecting these up without wiring disfiguring the ancient stonework. Thank you to Michael Bolton and Andy Sands for technical help with this.

# **Negus Window**

A new cover has been provided for this window to protect it from damage from outside.

#### Wi-Fi

Robert Pearson has kindly upgraded the Wi-Fi provision in church so that we can introduce a Contactless giving machine in 2023, free of charge, courtesy of the diocese.

#### **Electrics**

The electrical circuits in church were tested during the year, but unfortunately a wiring fault was found high up in the north isle of the nave necessitating the circuit to be isolated. When the electrician can get specialist lifting equipment it will be fixed.

#### **Donations**

The church has benefitted from donations of a new altar frontal for our small Nave altar and another matching wooden lectern to aid readers and those leading intercessions and two new lectern falls.

N.B The old eagle lectern is very unstable and consequently dangerous, and so it is stored safely in the side chapel.

#### **Family Centre**

During the year we have introduced an online booking system. This also enables intending users to have a look on the website to check availability. We have had a visit from Gedling Borough's environmental health team and were fortunately given a 5-star rating. A huge thanks to Karen and Ron for all their work in maintaining the kitchen. A new washing machine has been installed, paid for by the pre – school and a new dishwasher and microwave has been installed, paid for by the Community Kitchen which continues to distribute free cooked meals every Saturday. The church has paid for a new freezer. A new simple water stop control has also been fitted in the kitchen in case of a water leak and we await the fitting of a thermostat in the small hall so that its temperature can be regulated more easily. Unfortunately measures involving Severn Trent to install a water meter that is readily accessible to be read have all failed so far, but we keep trying!

# 22 St. Mary's Close

This is the house owned by the church that formerly housed a Youth Worker and is now rented out. In the early part of the year a considerable amount of money was spent changing the gas boiler, oven and fire and making it safe. Additionally, large amounts of mould started to appear on the inside walls. The churchwardens were concerned about the high cost of maintaining this property and so with the support of our Archdeacon we asked the diocesan surveyor to look at the property to assess its future. He stated that the house was still a good investment opportunity for the church and so we continue to rent it out. However, the PCC have decided to let a property agent look after it on our behalf from now on, an arrangement that seems to be working well. As churchwardens we are grateful for all the support given to us and the people who have advised us during our first year! A great big thank you to everyone, we truly couldn't have done this job without your help and support.

# **Gedling Deanery Synod Annual Report**

Synod met via zoom on March 9th, but we were thrilled to resume in person meetings on June 22nd and November 16th. In addition to our focus on Mission, we were visited by Robert Cleave, Diocesan Environment Officer, who gave a presentation about the importance of caring for creation. 2022 saw the launch of the Parish Refresh process to discern the next steps in our strategy for growing disciples. At each meeting, news from around the Deanery and from Diocesan Synod is shared. We hold discussions in small groups, and we pray for each other. We receive regular reports from Diocesan Synod with Revd. Sam Hustwayte still in post as Chair, as well as our lay representatives Michael, Peter, David and Muriel continuing to serve alongside Revd. John Allister. We also circulate regular reports from General Synod.

Revd. Margaret Caunt retired from St Mary's Arnold and Revd. Mic Johnson from All Hallows Gelding and Holy Trinity Lambley; Revd. Debs Moyet went to Canada to be Associate Minister at The Church of Our Lord, Victoria in Canada and Outreach Director at Street Hope, Victoria. Lay Chair Tony Mellor stepped down and we thank him for his work. The post of Lay Chair is currently still vacant.

Churches in vacancy- Netherfield continues in vacancy, joined by Carlton, Colwick, Lambley, Gedling and Arnold. Our churches in vacancy have continued their commitment to church life, with support from retired clergy and hardworking lay teams.

The post of Deanery Treasurer is still vacant. Please consider prayerfully whether you know anyone suited to this role. Encourage them to talk to our Area Dean, John Allister.

Across the Deanery, we were able to meet just 67.8% of our share allocation, with three churches managing 100% despite recent difficulties, which was greatly appreciated. After significant discussion and consultation, we continued to trial apportioning Parish Share for 2023 on an 'offer based' approach. Changes were made to the 'suggested' figures, using a formula based on 'agreed principles'. We recognise that this system was fair, while not perfect, and that many churches would not be able to meet their allocation.

2022 also saw the return of the popular Deanery Quiz. John made a demanding quiz master, and £190.20 was raised for Ukraine. There were teams from St Paul's Carlton le Willows, St Jude's Mapperley, St John's Carlton, St James' Porchester, St Paul's Daybrook, and St Mark's Woodthorpe. There were 17 teams, and approx. 100 people had a very enjoyable, if taxing, evening! We plan to hold another very soon!
